The curriculum leading to the Nursing Assistant Certification requires students to engage in diverse, complex, and specific experiences essential to the acquisition and practice of essential nursing skills and functions. Unique combinations of cognitive, affective, psychomotor, physical, and social abilities are required to satisfactorily perform these functions. In addition to being essential to the successful completion of the requirements of the Nursing Assistant Training Program (NATP), these technical standards are necessary to ensure the health and safety of patients, fellow students, faculty and other healthcare providers.

Becoming a professional Certified Nursing Assistant (CNA) requires the completion of an education program that is both intellectually and physically challenging. In order to be successful in completing the requirements for a CNA, students must be able to fully participate in both the academic and clinical environments. Below is a list of some of the technical standards required in the NATP. These are examples of learning activities that students will be required to participate in during the NATP and not meant to be an exhaustive list of all technical standards.

Students in the NATP must be able to:

- Participate in classroom, clinical, and laboratory discussions and learning activities.
- Solve problems within reasonable time frames in complex environments.
- Accurately complete data collection including but not limited to vital signs, skin inspection, measurement of nutritional and liquid intake, measurement of output, and resident complaints.
- Move safely around the skills lab, patient rooms and in a variety of clinical settings.
- Assemble and transport a wide range of equipment and supplies to and from resident rooms and other clinical care areas.
- Assist residents with mobility, which may include moving patients in and out of beds, gurneys, and chairs
- Demonstrate ability to safely transfer residents among beds, chairs, toilets, wheelchairs, and commodes.
- Demonstrate ability to carry out delegated duties.
- Assist residents with ambulation.
- Perform nursing care in a timely and safe manner including the provision of life saving interventions.
- Assist residents with psychomotor skills such as hygiene, feeding, transfers, dressing, and grooming.
- Accurately document patient care on paper and in the electronic health record in a timely manner.
- Communicate with residents, caregivers, family members, and other healthcare personnel in a manner that is clear, accurate, and ensures that the plan of care is understood.
- Develop therapeutic resident and family relationships.
- Establish professional relationships with faculty, other students, staff of affiliating agencies, and members of the community.
- Express feelings and ideas in a professional manner.
- Provide and accept feedback respectfully.
- Adapt to unexpected changes and stressful situations.
- Exercise good judgment.
- Empathize with the feelings and situations of others.
- Identify own emotional responses, be reasonably objective and maintain self-control during difficult situations.

Immunization requirements for health care workers, including students, are different than immunization requirements for the general population. These requirements are set by the program/clinical facilities where students provide patient care. 1. PPD (Tuberculosis skin test) - annual requirement

PPD for health professionals is a two-step booster process for the <u>first PPD</u>, then an annual one step process is required thereafter as long as you stay current with annual skin testing. The PPD test is given and then read in 48-72 hours. If the first one is negative, the PPD skin test is repeated the following week but no more than 4 weeks later. You must receive the two tuberculin skin tests within a month's time frame to be considered an actual two-step process.

If <u>positive PPD</u>, complete the <u>Tuberculosis Clearance Form</u> which is available in the SRJC Health Science office. Must complete a chest x-ray (within one year of admission). Bring a copy of a recent chest x-ray report to Health Science office for student file.

2. Annual flu (seasonal and H1N1) vaccination is now required by area hospitals based on California Health recommendations. Verification of immunization may be difficult to come by if the vaccination is received at flu clinics in the community setting however, it is required. Each student is to avail themselves of the vaccine at the SRJC Student Health Center, health care provider, or community flu clinics. We will require student's documentation to verify completion of this requirement every fall. The annual flu vaccines usually are released by the CDC by September each year. You will need to have the current flu vaccine in order to participate in this program.

Hospital employees are allowed to decline the flu vaccinations with a signed declination statement. Students however are not employees and clinical settings may decline a student if not fully immunized. Students who are unable to complete their clinical rotations will not meet course objectives and will fail the course.
